


## **Overview of Conference Proceedings Instructions**

Thank you for your interest in preparing a full paper for the proceedings volume of The 6th International Conference on ThermoMechanical Processing (TMP2022). The following overview may assist authors with some of the most common questions about submitting a full paper.

About the Publication	All the accepted full papers will be published in the conference proceedings.
Deadlines	The deadline for final, publication-ready full paper is April 15, 2022.
Page Limits	4~6 pages (6 pages at the maximum).
Formatting: All Publications	<ul> <li>The volume of TMP2022 will be published in one-column format, so please use the one-column template and instructions the follow. For all proceedings full papers, please use these tips to avoid common formatting errors:</li> <li>1. Paper</li> <li>The composition of a full paper should be the following: title, authors' names, affiliations, abstract, key words, introduction, body of paper, conclusions, references. See details in attached format sample.</li> <li>2. Typing</li> <li>The full papers will be published in one-column format, so please use the one-column template and instructions of the formatting overview. The printing should be in one column in good book face of 10.5 p in total of 45 lines. The margins for the page are 32 mm from upper, 22mm from left edges and right edges, 19 mm from bottom edges.</li> <li>3. Figures</li> <li>The words, letters and symbols in figures should be in 8.0 p, the vector and matrix in bold; and axis captions in coordinate graphics should be complete and should include measure words, units and symbols.</li> <li>4. Tables</li> <li>The numbers and titles should be above the tables, with three lines and auxiliary lines if necessary.</li> </ul>



## 5. Symbols

The symbols showing physic quantities, letters identifying points, lines and plans should be in italics.

6. References

References should be numbered in the order they are mentioned in the text. The reference section should be as the style shown below.

Book description format:

Main responsible person. Title (including subtitle, colon between main and subtitle) [document type designation]. Other responsible person (compiler). Edition (not written for the first edition), place of publication: publisher, year of publication:Page number.

**E.g** Grong M J. Metallurgical Modelling of Welding [M]. London: Institute of Materials, 1994, 1: 78-79.

Journal description format:

Author. Title of article [document type indicator]. Title, year of publication, volume (issue): page number. If there are more than three authors in the bibliography, use et al. instead.

**E.g** Mastri A R. Neuropathy of diabetic neurogenic bladder[J]. Ann. Intern. Med., 1980, 92(2): 316-318.

**E.g** Miyamoto G, Oh J C, Hono K, et al. Effect of partitioning of Mn and Si on the growth kinetics of cementite in tempered Fe-0.6 mass% C martensite [J]. Acta Materialia, 2007, 55: 5027-5038.


• Proceedings description format:

Author. Title of the article. See (In): Proceedings Editor. Proceedings title [document type designator]. Place of publication: Publisher, Year of publication: Beginning and ending pages of the article. If there are more than three authors in the bibliography, use et al. instead.

**E.g** Weistein L, Swartz M N, Qeistein L, et al. Pathogenic Propertics of Invading Microorganisma. In: Sodeman W A ed. Pathologic Physiology: Mechanisma of Disease[C]. Philadephia: Saunders, 1974: 457-472.

• Dissertation description format:

Author. Title [document type designation]. Location: Degree-granting institution, year.E.g Cairns R B. Infrared spectroscopic studies on solid oxygen:[D]. Berkeley: University of California, 1965.
