The sixth Sustainable Development Goal (SDG 6) seeks to ensure the availability and sustainable management of water and sanitation for all, focusing on drinking water and sanitation, the sustainable management of water resources, water quality, integrated water resources management (IWRM), water-related ecosystems, and enabling environment. The UN-Water Integrated Monitoring Initiative (IMI-SDG6) supports countries' monitoring of, and reporting on, SDGs.

This Seminar will cover major topics on how countries can better engage in systematic follow-up and review of progress towards the SDGs and their targets by using a set of global indicators, and how data and information concerning water use for all sectors are collected, measured and reported by different roles and responsibilities of custodians, as well as to share China's major progress in implementing water-related SDGs.
